# AIDS memorial design contest announced

The board of the National AIDS Memorial located in San Francisco is pleased to announce an upcoming design competition. This fall, we will be requesting submissions from architects, landscape architects, planners, artists, and students for a memorial feature in the nation's living memorial for all those lives have been touched by AIDS.

The National AIDS Memorial, a seven-acre grove in San Francisco's Golden Gate Park, was established by a group of local volunteers in a public/private partnership to create a place for hope, healing, and remember. In 1996, congress declared the Grove a national memorial, a status similar to that of the Vietnam's Memorial in Washington, D.C. It is the only federally designated AIDS memorial in the U.S.

It is the goal of the competition to identify a design of notable significance that will galvanize the Grove impact, visually and spiritually. The board intends to invite the authors of the winning scheme to enter into contract negotiations intended to lead to a commission, subject to the laws and statues of San Francisco and the state of California. The California entries will take place in August, with a submittal deadline in December 2004 entries will be adjudicated by a panel of internationally known artists and architects in January of 2005.

Any architect, landscape architect, planner, artist, or student of these disciplines (or combination of the above) may submit. If the designer of the winning scheme is not licensed

To practice architecture, landscape architecture, or planning in the state of California, they will be required to compose a team of professionals that is so licensed.

There is a fee of \$100 to submit an entry before November 1, 2004. Thereafter the fee will be \$150. Academic institutions may qualify for \$250 studio fee to cover several applications.


# Singh on cross-country trek for charity

# Continuing Education Committee

The objective of the AIA Columbus Continuing Education Committee is to provide educational and professional development opportunities to the profession of architecture through semilectures, nars. Charrettes and workshops. Monthly seminars are held before the chapter meetings. Additionally, the committee coordinates other full and partial-day seminars, often in conjunction with related professional associations (Construction Specifications Institute,

Builders Exchange, etc.). By attending these seminars, Chapter members may earn sufficient Learning Units (LU's) toward satisfying the annual 18 hour continuing education requirements of AIA CES and various state boards of Architecture. A committee of volunteers plans and organizes the seminars and events.

The AIA Continuing Education Committee develops its annual program offerings in an attempt to cover a broad range of topics corresponding to the following categories: Design, Practice Management, Leadership, Sustainability, Technology/Materials, and Project Delivery. This broad based approach to the creation of seminar topics reflects the breath of Architectural Practice and the varied interests of the Columbus Chapter membership. In calendar year 2004, fourteen out of nineteen seminars address

issues directly related to the Health, Safety and Welfare (HSW) of the public...a key requirement for AIA Continuing Education requirements and state registration compliance.

As it has done for the past four years, the AIA Continuing Education Committee helped to organize the chapter's annual Design Charrette on April 16th. This year the Design Charrette was developed in conjunction with the Greater Columbus Arts Council and the Columbus Downtown Development Corporation coinciding with the CDDC's two month long Urban Life exhibit focusing upon downtown housing. The Design Charrette has always encouraged participation by students of architecture programs at The Ohio State University and Columbus State Community College, but for the first time this year welcomed students and faculty from Columbus College of Art and Design due to the Charrette's focus on Artist Live/Work Housing.

This year, for the first time, the AIA Continuing Education Committee will work with the AIA Architecture Columbus Committee to develop a program of seminars, presentations and events titled, "In-Design" to be developed to attract both architects and contractors to forums addressing subjects of common interest and fostering dialogue and understanding between the profession and the community. The "In-Design" seminars will occur in November in conjunction with the activities surrounding Architecture Columbus.

In 2001, the Chapter's efforts were recognized on a national level when the Chapter was awarded the AIA Continuing Education System's Award for Excellence. The award recognizes the high quality of the Chapter's educational programs.

2004 continues to be a busy year for the AIA Continuing Education Committee as well as an exciting year for the AIA Columbus Chapter membership while simultaneously facilitating the life long learning objectives of the National American Institute of Architects.
